# Slow No-Wake Expired August 8th


A Slow No-Wake was issued by the Aitkin County Commissioners along with the Aitkin County Sherriff effective from July 14 through midnight August 8. This was an entire lake no- wake. It also included Little Pine Lake, which connects to FIL on the north end. For more information, please see the Aitkin County Sherriff on Facebook.

A special thanks to all of you who have been understanding and compliant. The water level is still high so we ask that you take this under consideration while enjoying the lake.

The record high for the lake in 2012 was 1257.25" and was 1255.5" on July 16, 2016. This is about 2 inches above the trigger elevation.

## **AIS Update**

Subject: August 5,6, and 7 Aquatic Invasive Species (AIS) inspections and decontamination units

Hello: As we move along through the summer of 2016 it is hard to believe that we are already thinking about Labor Day weekend just one month away! The inspectors will be out at area lakes this weekend to continue to educate the boaters on the importance of AIS prevention. We staff 17 accesses throughout Aitkin County on a very regular basis, and we add about 4 or 5 other priority accesses each weekend. We hope to have contact with most lake users at some point throughout the boating season.

In addition to the county AIS inspectors we have great support from conservation officers and the Aitkin County Sheriff's Office. According to Sheriff Turner, there are additional boater contacts carried out by the Sheriff Department Deputies. To date, about 300 additional contacts have been made (this adds to the about 6000 inspections so far by our regular inspectors). Our message is consistent that lakes are extremely important and everyone needs to do their part to keep the lakes healthy and free of aquatic invasive species. The 3 decontamination units will be staffed all this weekend and available to spray down boats, trailers, bilge areas, and live wells with heated water to kill any AIS that may be attached.

Volunteers recently concluded zebra mussel veliger (microscopic young) sampling. This sampling involves pulling a funnel-shaped net through the water column to look for any AIS, especially zebra mussels. In 2015 10 major lakes in Aitkin County were sampled and all were free of zebra mussels. A similar effort was done in 2016 in mid-July. July and August are the peak times for zebra mussel activity.

We plan to conduct inspections through Labor Day.

Watch for the 2017 grant application for AIS funding and inspector hours. This is planned to be ready by about August 15th. This is an Aitkin County Grant using a portion of the State AIS funding. The process will be very similar to the grant process from 2016. Our goal is to keep the application as short and simple as we can.
