Highway 210 was closed on Tuesday morning, July 9. The detour uses Highway 25 in Brainerd, Highway 18 to Highway 6 in Deerwood, then Highway 6/Highway 210 to Crosby-Ironton. As part of the detour, you will encounter a temporary mini-roundabout at the east intersection of Highway 6/210 in Deerwood. Also, be alert for trains. Highway 6 has a railroad crossing just south of the intersection. When a train goes through Deerwood, all traffic on Highway 6 and Highway 210 will come to a complete stop at the roundabout.

Higher boat fees will help keep lakes clear

As watermilfoil, starry stonewort and other invasive weeds continue their incursion into Minnesota's lakes, the state has resumed a popular grant program to help local lake associations fight back.

The Minnesota Department of Natural Resources (DNR) began collecting an increased fee this week on boat registrations — the first increase on a special surcharge for invasive species management in more than 20 years. The increase, \$5.60 per boat, is expected to raise about \$900,000 over the next two years.

The bulk of that money will go to lake associations, cities and counties to help pay for lake testing, chemical spraying and inspectors to monitor public boat launches. The grants will have to be matched by homeowners or other local sources.

Lawmakers stopped funding the grants two years ago during a period of state budget cuts, causing home- and cabin owners on lakeshores across the state to either cut back their efforts or pay more out of pocket. Property owners argued that those costs should be shared by all Minnesota boaters who use the lakes and share responsibility for spreading invasives, which can latch onto boats and be carried to uninfested waters.

DNR officials hope to start issuing grants by the end of the summer, but the majority of the money raised won't be used until next year, said Heidi Wolf, DNR invasive species unit supervisor.

"There will be some treatments, but there won't be much this season," Wolf said. "Usually a lot of [the grants] go out in the spring because that's when you treat for curly-leafed pondweed and Eurasian watermilfoil."

The DNR will set aside \$100,000 this year as an emergency fund to immediately target any new breakouts of starry stonewort or zebra mussels, which are particularly aggressive and damaging to native fish and plant species as well as pipes and culverts. If the state sees no new infestations, the DNR will use that money next year to offer more treatment grants to lake associations and municipalities.

The return of the state grants will be welcomed on Lake Minnetonka, which attracts about 62,000 boat launches from its public access points every year, said Eric Evenson, director of the Lake Minnetonka Association.

"We're glad it's back. It's a good start. But the nature of the problem is much greater than the resources that are being put into it," Evenson said.

Lake Minnetonka has been infested with watermilfoil for decades. The Lake Association is now spraying the weeds in six bays of the large lake with some success. Depending on how bad the infestation is, the association might pay up to \$15,000 to treat a single bay in a year. The grants would help either alleviate some of that cost for homeowners or increase the treatments on Minnetonka.

Showing results

In Lake Minnetonka, the treatments are starting to show results, Evenson said. Some years, the milfoil doesn't show up at all in bays that had been infested. And, for the first time in a long time, people are starting to see native plants grow in certain areas of the lake, Evenson said.

"That's pretty exciting because we know that if we can get healthy native plants to grow, that will make it a little more difficult for these invasives to come in and take hold," he added.

About 75 miles northwest of Minnetonka, Rice Lake near Paynesville has avoided watermilfoil so far but has been fighting starry stonewort weeds for the past four years.

The Rice Lake Association and Stearns County have been spraying and monitoring the infestation in an effort to keep it contained to the areas near the public boat launches where it has taken hold, said Susan Anderson, Lake Association president.

"Everything we get, we use for surveys, inspections and chemical treatment," Anderson said. "Without it, I don't know what we'd do."

Anderson said she's glad the state has found a way to spread the cost of fighting invasives across all boaters, not just cabin owners or counties with infestations.

"These are all public waters and we know that these species are transported mostly by boat," she said.

On its surface, the problem of AIS is simple; if we stop moving infested boats and water related equipment from one lake to the next, we will stop the spread. It is that simple.

But, as is often the case, the MN DNR is caught between two competing public goods with AIS efforts.

Lakes, and lake based recreation, are critical to local economic health and tax base. These benefits only accrue with use of the lakes. Lakes that are either so infested as to lose their recreational value, or so restricted as to prevent access will BOTH impact the local tourism economy.

Does providing access mean simply putting in a boat ramp, even if the lake is so choked with starry stonewort navigation is impossible, or if, in the case of Mille Lacs, the walleye has been so impacted by zebra mussels and spiny water flea that anglers cannot keep a fish?

Or does access mean access to a healthy resource, to vibrant fisheries, clean water, abundant waterfowl? Does access refer only to a means of putting a boat in water, or the ability to enjoy healthy waters. What limits access more, a controlled boat ramp, or a lake so choked with starry stonewort no one visits it.

You have been living and working within this conflict right alongside the MN DNR. This open, public and moderated discussion will help frame the issue for the future. It is time to make your voice heard.

This is a great moment for us to be heard. Register today and make your voice heard in this important discussion.

The MN DNR is hosting three public meetings to discuss these access issues and your voice is needed. The results of these discussions could inform policy for years to come.

Note: When government, local agency, city and county information is included we are serving as the messenger to keep you informed of their activities on Farm Island Lake.

Minnesota law requires water recreationists to:

- **Clean watercraft of all aquatic plants and prohibited invasive species.**
- **Drain** all water by removing drain plugs and keeping them out during transport.
- **Dispose** of unwanted bait in the trash and dispose of bait water.
- **Dry** docks, lifts, swim rafts and other equipment for at least 21 days before placing equipment into another water body.

2018 AIS Inspection Final Results

- Greg Anderson and Bill Haroldson created and presented a PowerPoint report on the 2018 AIS Inspections and Background Data. This report is on our website at <https://filialake.wixsite.com/filia/aquatic-invasive-species-activities>.

- Approximately 20 boat landings throughout Aitkin County had inspectors present in 2018. ...Of the 250 AIS issues, 155 of them were for drain plugs still in the boat upon arrival, 94 were plants, water, mud, etc. on the boat or trailer. Once again, the busiest lake was Farm Island, with Big Sandy coming in 2nd, and Cedar in 3rd. A chart and information is in the full report, which can be found on the FILIA website.



There were no zebra mussels found in Farm Island Lake. They have been found in Bay Lake and Big Pine, so they are a near and present threat to Farm Island Lake.

The DNR AIS program addresses invasive species in Minnesota, such as Eurasian watermilfoil, purple loosestrife, zebra mussel, spiny water flea and starry stonewort. Efforts in this area include working to prevent further spread and to manage impacts from invasive populations. 1. Hourly wage is \$12 - \$14, depending on training level and experience. Volunteers are also welcome.
2. Part-time, seasonal work from the Friday before fishing opener (mid-May) through Labor Day.
3. Schedules cover Friday afternoons, Saturday, Sunday, and the summer holidays.
4. Training cost is paid by Aitkin County.

A cool \$100

County offers a \$100 reward to those who leave these items out of the water for 30 days.

Between June 1 and Nov. 30, Aitkin County is offering an incentive to combat the spread of aquatic invasive species. **According to state law, docks or boat lifts must be out of the water for 21 days before they are moved to another body of water or sold.** A new program through Aitkin County offers a \$100 reward to those who leave these items out of the water for 30 days.

Aitkin County started a program June 1 especially for movers or sellers of docks and boat lifts. Since July 2012, Minnesota law states that any boat lift, dock, swim raft, or associated equipment that has been removed from any water body may not be placed in another water body until a minimum of 21 days have passed. Now people moving or selling those items can be rewarded \$100 just for leaving a dock or boat lift out for nine extra days for a total of 30 days on land (the dock or boat lift must have been in the water in the current open water season). The program runs each year from June 1 through Nov. 30.

If you are in an association you need your own number, placed by your individual house, so you can quickly be located. To order, contact the Aitkin County Highway Department 218-927-3741. In an emergency, be able to give detailed directions on how to reach you. Write it down, and post it so everyone at your house can see it.

Curly-Leaf Update

Pond weed (curly-leaf) is not as prevalent this year due to the heavy snow on the ice this winter. End-of-Year 2018 the DNR reported that they did not do a Curly Leaf survey that year, but it was diminished on many lakes and they would expect the same on Farm Island Lake. It grows in the winter-time; and when there is a lot of snow you get less curly-leaf because it doesn't get sunlight. Your FILIA board will request a survey for this year. Walleye Population

The DNR will continue to monitor walleye population using electroshock and gillnetting, and stocking walleye fries in Farm Island Lake every year. See Gillnet Catch Rates and electrofishing reports on the FILIA website. 🗨️ All walleye from 16-19" in length must be immediately released.

A diver down flag, or scuba flag, is a flag used on the water to indicate that there is a diver below. This flag will also be displayed on the diver's boat.

All vessels, boats, jet skis, etc. should **stay at least 200 feet away when they see a SCUBA flag.**

- 2) Improve and preserve the quality of the land and water in the FIL area for its members, the community and future generations.

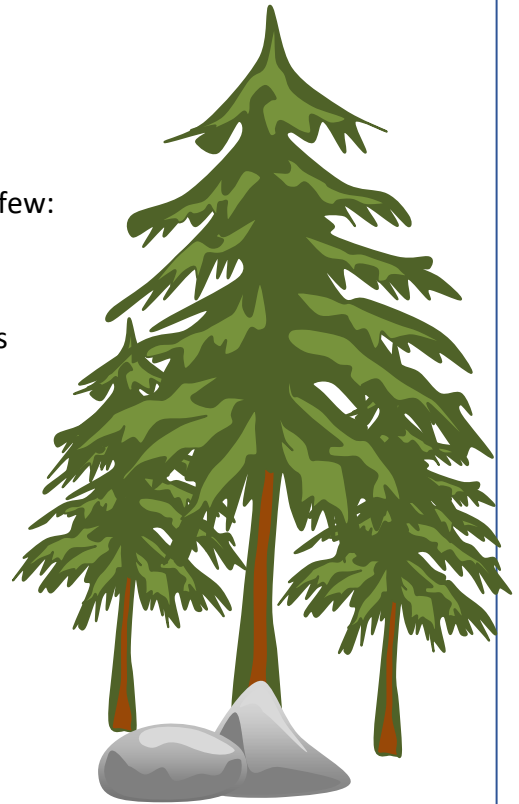
Some examples of how we strive to meet our mission are:

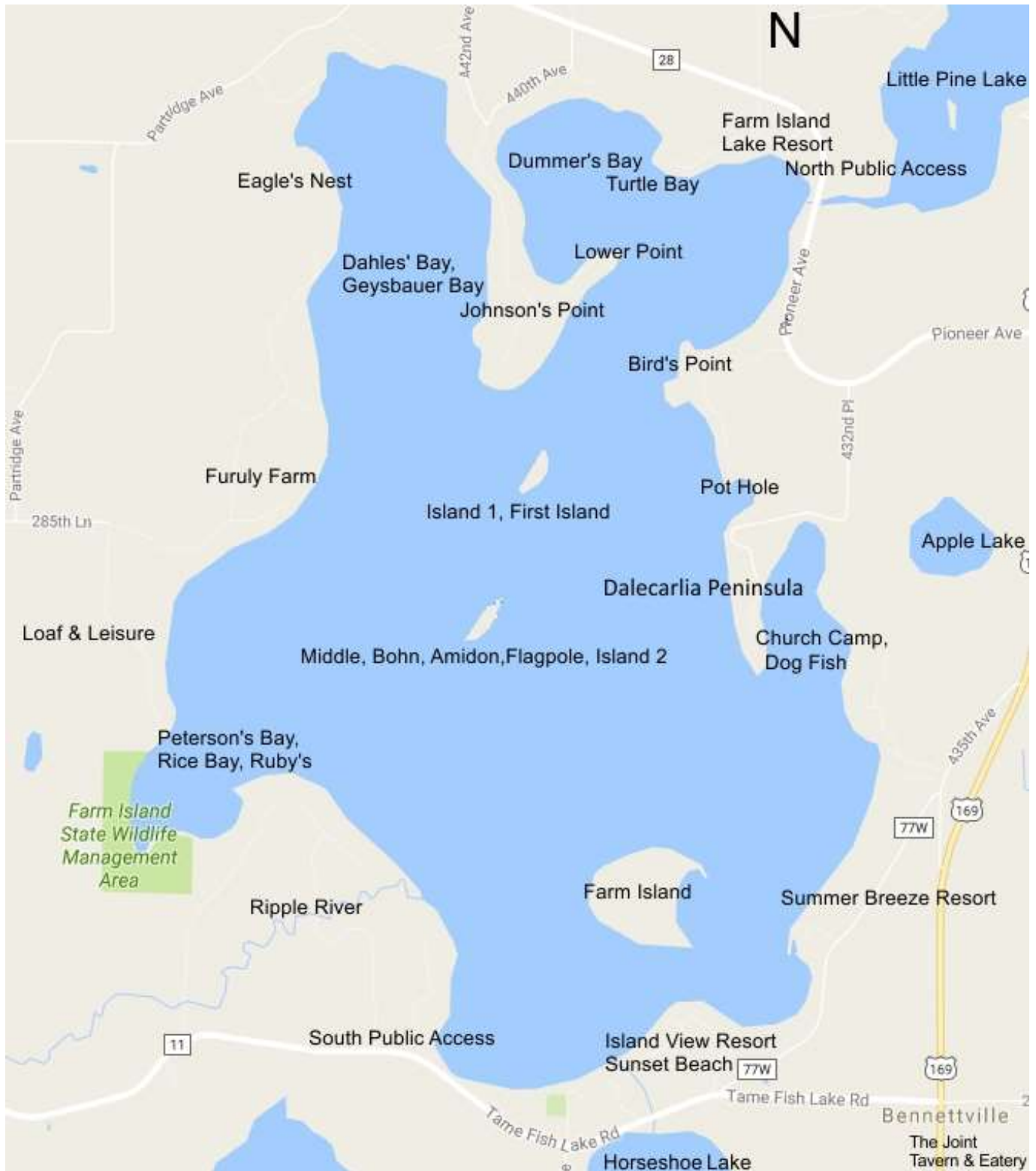

Clean In Clean Out

When boating or fishing in Minnesota, protect your waters by following state aquatic invasive species laws.

1. **CLEAN** all visible aquatic plants, zebra mussels, and other prohibited invasive species from watercraft, trailers, and water-related equipment before leaving any water access or shoreland.

2. **DRAIN** water-related equipment (boat, ballast tanks, portable bait containers, motor) *and* drain bilge, live well and baitwell by removing drain plugs before leaving a water access or shoreline property. **Keep drain plugs out** and water-draining devices open while transporting watercraft.

3. **DISPOSE** of unwanted bait, including minnows, leeches, and worms, in the trash. It is illegal to release bait into a waterbody or release aquatic animals from one waterbody to another. If you want to keep your bait, you must refill the bait container with bottled or tap water.

KNOW THE LAW: You may not...

- Transport watercraft without removing the drain plug.
- Arrive at lake access with drain plug in place.
- Transport aquatic plants, zebra mussels, or other prohibited species on any roadway.
- Launch a watercraft with prohibited species attached.
- Transport water from Minnesota lakes or rivers.
- Release bait into the water.

ADDITIONAL RECOMMENDATIONS

Spray, rinse, dry — Some invasive species are small and difficult to see at the access. To remove or kill them, take one or more of the following precautions before moving to another waterbody, especially after leaving zebra mussel and spiny waterflea infested waters:

- **Spray** with high-pressure water
- **Rinse** with very hot water*
- **Dry** for at least 5 days

Run motor and personal watercraft for a few seconds to discharge water before leaving a water access.

Transport fish on ice — be prepared, bring a cooler.

* These water temperatures will kill zebra mussels and some other AIS: 120°F for at least 2 minutes; or 140°F for at least 10 seconds

Report suspicious infestations

If you suspect a new infestation of an invasive plant or animal, take a photo and note the location, or save a specimen and report it to a local [DNR invasive species contact](#).
